Property is a mixed-use 3-story building containing 1806 SF of finished space, plus approx. 602 SF of unfinished basement for storage, accessible by stairs from the 1st floor.

It is located in the Downtown Baltimore Enterprise Zone (zoned C-5-DC), across the street from the new Lexington Market, 2 blocks from the Hippodrome Theater, UM Law School, UM Medical Center, 8 blocks from Convention Center, Camden Yards, less than a mile from Inner Harbor and all the fabulous amenities downtown has to offer. Both units recently renovated – new central air, updated electrical systems and plumbing, and new roof. The 1st floor (602 SF) is storefront retail/office and has new vinyl plank floor, new drop ceiling and ADA bathroom. The loft (1204 SF) has a separate entrance, is comprised of the 2nd and 3rd floors, has 12' ceilings, exposed brick, hardwood floors, new Low-E soundproof windows, recessed lighting, wood veneer cabinets in kitchen with dove tail-drawers and soft-close drawers and doors, SS appliances (refrigerator and D/W recently replaced). Stairs from the street lead to an open area with living room, dining area, eat-in kitchen and laundry closet. A second set of steps lead to a landing, then a large, open bedroom with closet and bathroom. Both units are currently rented under mo-to-mo leases at \$1,350/month for retail and \$1,500/month for loft. Parking garage across the street at \$90/month.
